Official Rules

*This grant of Twelve Hundred Dollars (\$1,200) will be made to a student to defray the cost of tuition, books, fees, or room & board at an accredited institution of higher learning approved by the Colorado Rural Water Association (CRWA). Distribution of the money will be made upon presentation of winner's college/university invoice as proof of full-time enrollment. Because the scholarship money is distributed directly to the student, the recipient will be required to complete an IRS Form W-9, and will receive an IRS Form 1099 at the end of the tax year. Children, step-children or dependents of full-time employees of active CRWA System Members or CRWA are eligible to apply. Applicants must be residents of Colorado, 26 years of age or less on September 1st of the upcoming school year, and **must complete the official application form in its entirety by completing all blanks. If an item is not applicable, write N/A in the blank.** Upon completion, return the application to CRWA by the postmark deadline, June 20, 2018. All applications will be first screened based on leadership responsibilities in community and school activities and the grade-point average. In addition to initial screening criteria, the length of commitment, awards & honors received, the relationship of career goals to the water and/or wastewater industry, and financial need will be considered. Applicants will be evaluated on a comparative basis at the discretion of a committee assigned by the CRWA. Decisions will be final. Application material and decisions of the committee shall be confidential. Acceptance of a scholarship constitutes permission to use the recipient's name and/or likeness for recognition and promotion of the scholarship program and CRWA.*
